# **Annual Meeting of PMCPOA Membership is June 17**

The 2017 PMCPOA election takes place at the Members' Meeting on Saturday, June 17, when three new members of the Board of Directors will be elected to three-year terms. By now, you should have received the election packet in the mail. If not, please contact the Business Office immediately at (661) 242-3788.

In accordance with the Civil Code, you are being provided with a mail-in secret ballot for your vote. If desired, you may bring the mail-in ballot to the Annual Meeting and hand-deliver it during the registration period. Registration for hand-delivered ballots opens at 12:45 p.m. and ends with the closure of the polls at 1:00 p.m. Voting will take place until the hour of the election at 1 p.m. An Inspector of Elections will tally the votes, with the winners to be announced immediately thereafter.

The meeting will be held in accordance with the bylaws of the Association to elect the three new members to the Board of Directors and to transact other business as may be properly presented and discussed at the meeting. In order to conduct the annual meeting, a quorum of at least 25 percent of the membership entitled to vote must do so by mail or in person. If the lack of a quorum results in adjournment of the annual meeting, a second meeting will be immediately convened with a quorum of 15 percent in accordance with the Bylaws.

#### Board Approves E.C. Code Change Regarding Vehicles

During its May meeting, the PMCPOA Board of Directors approved by motion E.C. Code 7.22 D (1). It reads as follows: "1) As used herein, the term "Commercial vehicles" shall be defined as stated in section 5.11 of the CC&Rs. A commercial vehicle may only be temporarily parked on the lot or the street during the time the operator of the commercial vehicle is delivering goods or is providing services to the owner or occupant of the residence. Personal vehicles with advertising decals may be parked on the property, but in no case can any advertising decal be larger than 200 square inches (e.g. 12" x 16.6") and no more than three such decals on any personal vehicle. If a personal vehicle has any advertising decal larger than 200 square inches and/or more than three (3) decals as described above, it must be screened from view by an earth-toned cover or tarp, anytime it is parked on the property."

Also during the meeting, the Board ratified the Association Rules and EC Code. Copies of these are available for members to pick up at the front desk.



#### **Brush Clearance**

This year, brush clearance for the county needs to be completed by June 1<sup>st</sup>, 15 days earlier than in past years. Please look over your lots and make sure you have met this important deadline. Property owners are responsible for the proper maintenance of their lots. This includes keeping all aspects of the lot, including vegetation and all improvements, in a neat and well-maintained condition. The Kern County Fire Department will be focusing this year on grasses and weeds, in addition to normal defensive space requirements.

#### Fire Safe Council

This brings me to a troubling item that affects us all here in PMC. The Mt. Pinos Fire Safe Council is just about to shut down. The work they have done, especially since the Day Fire, has been fantastic. But the same volunteers who have been running it for the past seven or eight years are tired and need to turn the reins over to some new people. They have held on as long as they can, and no new volun-

teers are stepping up to the plate. The local Fire Safe Council was responsible for getting tens of thousands of dollars for local fire prevention-related projects, including the numerous sections of the shaded fuel breaks, dip tanks and the list goes on. Please contact the council if you can donate time and expertise; they need money to renew the insurance policy, they need a new president, vice president, secretary and treasurer for a 501c3, a grant writer and other volunteers. The bylaw 5.06 says in part, "Once any proposed bylaw amendment is received by the Board of Directors, the Board shall cause the proposed changes to be considered by the association's general counsel for general counsel's opinion as to the legality of the proposed amendment." This was a very narrow mandate and it was accomplished. The amendments were found to not be illegal in the current form, and thus could be placed on the ballot. But that is all. They were not reviewed at that time for conflicts, enforceability or a plethora of other issues that might need to be looked at.

#### Final Notes

- All trails or paths outside the golf course, unless specifically authorized, are off limits to motorize machinery. This includes ATV's, golf carts, motorcycles, electric carts, side-by-sides, etc. Also, if you see any acts of vandalism of association property, please call the sheriff's office or Patrol and report it.
- The Concert on the Greens series kicked off on Memorial Day weekend with plenty more to come. There are new food offerings, a green golf course, and the opportunity for more fun than we should be allowed to have. As always, stop by the lobby and see the flyers for details.

#### Clubhouse Remodel Is Controversial

The clubhouse remodel is so controversial that divided not only our community but even families.

Planning Committee doesn't have a plan for the project, only an idea, so nobody can estimate construction cost. Without engineering plans it's all speculation. Comparable structures are Frazier Park library \$6.3 million and PMC fire station \$5 million. Library has about 10,000 square feet compare to the clubhouse 24,364 square feet. Based on that our cost will be \$15,350,000 plus new swimming pool \$680,000. Parking, commercial kitchen,

golf simulator, weight lifting room, fiber optics and other upgrades will add even more. Size of the clubhouse will increase 275 % so members call it Tai Mahal.

Proposed structure location is appx. 1000ft from the San Andreas Fault and over high level underground water, which will not only increase substantially construction cost but it might cause structural failure during an earthquake.

Raising assessment to build the clubhouse will cause more lots foreclosures decreasing revenues and forcing even more assessment's increases. In 2016 there were 129 lots in foreclosure or surrendered to POA. Association revenues are down \$295,194 this year compares to 2011

dings." It is a falsehood that this fundamental change to our community can be built for \$6,000,000-\$7,000,000. More like double that is likely. Worse, the increased traffic will trash our precious air quality.

**Response:** Thank you for your opinion on this starting point for a facilities and member services improvement plan.

· The other day, my husband was driving his golf cart down Woodland toward the golf course, as he has done for the last 26 years. When he saw a vehicle approaching in his rear view, he went as far right as he could to let him pass. An angry man in a gray pickup nearly sideswiped him, and stopped to tell him that he is sick of people in golf carts slowing him down. My husband explained that these are private roads, and that PMC allows golf carts on their roads only. The man angrily insisted that PMC has now allowed CHP and sheriffs to patrol our roads and ticket vehicles that are not "street legal." I would like to know PMC's position on this and, if we ARE allowed to use our golf carts on PMC streets, to post a sign saying so.

**Response:** Sorry your husband encountered one of our less-than-amiable community members. Golf carts are allowed on our private roadways/streets. Kern County is very aware of this, as you can plainly see with the Golf Cart Crossing signs on Mil Potrero Highway at Freeman Drive and Symonds Drive. Those signs would not be there if golf carts were not legal on PMC streets.

• We will be able to vote on the "remodel" of the clubhouse. I've heard that the Board counts the foreclosure lots as a vote in favor of the remodel. Is this true? I don't feel these lots should be counted at all because they are "not in good standing."

**<u>Response:</u>** PMCPOA does not cast votes from the foreclosed lots.

• My husband and I have owned our cabin in PMC for 13 years now. The association fees have more than doubled in this time. Now it's going up another \$46. If the plans go forward on the "remodel" on the clubhouse, not only will the cost go up, the association fees will probably continue to increase also. How can we sustain the additional costs and still live here?

There have been so many foreclosures already. How many more will there be if the "remodel" goes forward?

**Response:** To assume all properties that were foreclosed on were due to the costs of annual assessments is not supported by facts. Just the minimum wage since 2004 has risen 56%. Benefits such as medical insurance have risen even more, and the assessment has gone up about 70.5% during that same time. We can be certain that with the minimum wage set to increase another approximately 43% in the next few years, there will most likely be assessment adjustments. We still believe that this is one of best performing Common Interest Developments (CID) in the Southern California area.

#### **COMPLAINTS**

• I feel that the Board hasn't been forthcoming with the members. Example: when the idea about taking over the post office was decided, we never heard ahead of time that if we took over this function, that we would have to pay more for health insurance since this would make more than 50 employees. This will be another "extra" cost to all the members.

**Response:** We are sorry you feel that way, however, in this case, we believe your feelings are misdirected. The Association is already a "large employer" for all regulations, and a "small group" in terms of being able to source the best medical insurance. Having staff in the post office has not changed any of those dynamics at all.

• As Condor mailing volunteers, the folding of the Condors has been very difficult for us and many others. Most of the group are senior citizens and our hands and arms do not take strain very well!

**Response:** First off, thank you so much for volunteering for this very important task. We are aware of the increased workload and we are doing two things: First, we continue to see if we can source a folding machine capable of folding our newsletter that will not break the bank. Secondly, we continue in our efforts to get more volunteers to spread the workload out a little more to make it easier on everybody. This is usually a once-a-month weekday morning endeavor with a lot of great people.

**Note:** If anyone would like to help out this

great group of mailing volunteers, please notify the reception desk, and they will put you in touch with the leader of the volunteer group.

• We need a public phone. Many part-timers have neither cabin landline phones nor cells that work here. A public phone is our only voice connection to the world. The last public phone, in Lampkin Park, has been removed, and I've heard will not be replaced because a) the club made no money off it, and b) public phones are obsolete. I'd point out the club has decided to subsidize indoor snail mail pickup for a minority of members to the tune of \$20,000 per year, (though) snail mail (is) also becoming obsolete. I'm asking the club to be equally kind to its now phoneless members by establishing a new public phone, perhaps at the clubhouse where vandalism should not be a problem. Thank You.

PS: While the three-minute local courtesy phone is nice, it's useless for calling home, dealing with contractors, etc., which require more time and off-mountain calling. We need a public phone.

**Response:** Thank you for the note. We continue to look into this issue and are searching for a long-term, viable plan that addresses the absence of a public phone and other issues along the same lines. The part about the club not making money was not the deciding factor at all for the removal of the phone in Lampkin Park. It was primarily because of the continued vandalism and the difficulty in sourcing parts, etc.

but expenses are going up. Bistro is losing around \$20,000 a month plus utilities and maintenance. Utilities, insurance, property taxes and additional staffing for the new clubhouse will raise expenses substantially.

There are many members on fixed income living here, who rarely go to the clubhouse and will have a hard time to pay hundreds dollars more in assessment fees. They might be forced to sell their homes.

#### Board-Approved Bylaws Deserve Scrutiny before Voting

On the June ballot the Board asks us to ratify two revised bylaws crucial to how

PMC forms its annual budget. Unfortunately, the ballot's explanations of the changes to bylaws 10.02 and 10.03 are insufficient and partially inaccurate, and the original bylaws have already been modified on the website. A truly informed vote has therefore been made impossible for most.

For example, the original 10.03 requires a nearly two-month budget formation process that begins with publishing financial statements, a requirement at least partially enforced the last few years. The revised 10.03 omits this requirement, and thus does not, contrary to the ballot explanation, "reflect the actual process being used by the Association in developing the annual budget." Specifically, the revised bylaw omits making available to members in advance of the budget meeting a draft budget, a written summary of a year-to-date budget, and a comparison of actual vs. budgeted expense for the whole fiscal year. The ballot explanation neglects this omission.

Dropping the financial and operating statements from the budget formation process does not reflect the current budget process and has no relevance to Civil Code 5300, which is the only other explanation offered.

It is a mystery to me why the BOD re-
