Please Help Keep Wildlife Wild

The time of year has arrived when bears are foraging daily for food to bulk up for the coming winter, and sometimes are finding easy access to human edibles due to the careless behavior of humans. There is plenty of natural food for bears outside of town, but they will come into town to look for an easy meal.

Please, remember to roll up your car windows and lock the doors. Bears CAN and DO open closed car doors, even if there is no food attractant inside.

Please, remember to close your garage door when you are not in attendance – day or night. Bears have learned that many garages have freezers/fridges and pet food in them and will walk right in and help themselves.

Please, remember to close lower windows when away from home, or before you go to bed. In the past, some folks had forgotten to close ground floor windows and arrived home or woke up to a bear sitting on the kitchen floor eating ice cream (a favorite) right out of their freezer. The damage to your home can be tremendous from bear intrusions.

Please, remember that bears follow their noses! They'll follow their noses right to your car or garage if you leave trash outside. Many times bears have ripped garage doors open to access trash. At my house, I put stinky trash in my spare bathroom overnight to take to the Transfer Site the next day. This is just a suggestion that has worked for me.

If you do have a bear break into your home, garage or car, CALL PMC PATROL as soon as it is safe to do so. Patrol officers are trained in the best hazing techniques available. No – we DO NOT kill them, but we make it a painful experience with a paintball gun to the rear end. We have had multiple meetings with CA Fish & Wildlife, and have their permission to use this intense hazing technique when necessary. PMC Patrol also reports habituated bears that have become a true nuisance to

BARBECUE SAFETY TIPS

Emergency Preparedness Committee

Summertime is barbecue time. But those grills can also be a fire hazard. Here are some simple tips to make your summer grilling safer:

- Propane and charcoal BBQ grills should only be used outdoors.
- All barbecues must have a closed cooking unit.
- The grills must be placed well away from the home, deck railings, and out from under the eaves and overhanging branches.
 - Keep children and pets at least 3 feet from the grill.
- Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill. Clean after each use to avoid attracting bears!
- Never leave your grill unattended. Keep a fire extinguisher, bucket of water or a connected water hose nearby, or all of the above.

CHARCOAL GRILLS

- There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to ignite the charcoal using only newspaper as a fuel.
- If you use starter fluid, use only charcoal starter fluid. Never add starter fluid or any other flammable liquids to the fire. Keep lighter fluids out reach of children and away from heat sources.
- If you use an electric charcoal starter, be sure to use an extension cord rated for outdoor use.
- Place grill on fireproof base materials to protect decks from hot coals and sparks.
- When finished grilling, let coals cool completely before disposing of them in a metal container.

PROPANE GRILLS

- Always make sure your gas grill lid is open before lighting it.
- Check the gas tank hose for leaks before using it for the first time each year. Apply a light soap and water solution to the hose. A leak will release bubbles.
- If your grill has a gas leak, by smell or soap test, and there is no flame, turn off the gas tank and grill. Replace the hose, and if you still have a leak have it serviced by a professional before using it again.
- If you smell gas while cooking, immediately get away from the grill and call 911. Do not move the grill.
- If the flame goes out, turn the grill and gas off and wait at least 15 minutes before re-lighting it.

Reminder: PMC EC Code 7.13- There are no open fires allowed in PMC. You may barbecue using charcoal briquettes only, not wood. Open fires, including fire pits and chimineas, are prohibited in PMC.

Vicky Kraft, our local "bear lady," is an invaluable source to assist anyone who wishes to "bear-safe" their house, even after a break-in. Vicky welcomes all calls for assistance. The PMC Clubhouse has helpful literature in the lobby published by CDFW on the subject of living in harmony with wildlife.

Please, remember that a bear walking through your yard, or just down the street, is not a threat. Black bears are omnivorous foragers, not hunters. They will not hunt down and attack you or your children or your pets. Bear-inflicted injuries on humans almost always happen because the bear feels threatened or trapped. Unleashed dogs that run up to a bear frantically barking have been injured or killed with one defensive swipe of a huge paw, but bears will not chase down your dog or cat to eat it. It just doesn't happen.

Please help keep PMC the beautiful

mountain community we all know and love. Enjoy the wildlife from a distance, and don't panic if you see a bear walking down your street.

Transfer Site Trouble-Shooting

Environmental Control Committee

Most members are respectful and very aware of the need for our Transfer Site.

Can you imagine having to take all your trash to Lebec? And, the money received for our recyclables helps to defray the cost of operating the site.

With new members moving into the community regularly, it's important to remind the membership that the Transfer Site operates under federal, state and local regulations. These require that disposal of Pine Mountain Club refuse meet stringent standards, including waste separation. Those regulations are outlined in Article 18 of the Association Rules.

It is very important for us all to SORT all materials according to the labels on the containers. Bins are provided for: (a) ashes (b) aluminum cans (c) plastic separated by white or milk, clear, CA redemption, plastic #2 and up, and colored (d) newspapers (e) magazines (f) phone books (g) glass separated by blue/green, clear, and brown/red (h) scrap metal (i) electronic waste (j) appliances, and (k) cardboard.

Also, please carefully study the list of items NOT allowed at the site. Prohibited items include: hazardous waste, dead animals, explosives, poisons, pesticides, infectious wastes, friable asbestos, tires, sewage sludge, mattresses, large furniture and construction materials.

Our site is for member household items, NOT large dumping of construction materials.

Those items need to be taken to Lebec. Our workers spend time keeping the site as neat as possible. We, the residents, sort our own rubbish. It saves our employees time. Remember, time is money, and in this case it's OUR money.



If you are a landlord, please share these regulations with your tenants. The restrictions listed below exist in the PMCPOA Governing Documents; violations will result in fines to the property owner and tenants.

not drop ashes or cigarettes on the ground.

- Watch for rattlesnakes when walking in the forest or on your property.
- The discharge of firearms or fireworks is strictly prohibited, as is hunting.
- Open flame barbecues, campfires or fire pits of any kind are prohibited. Barbecues must have a closed cooking unit. No open flames are allowed at any time. Keep an extinguisher or water nearby. There is a \$500 fine for a first offense.
- Pedestrians are not allowed to walk on the golf course.

Consideration For Others

- Please respect your neighbor's privacy and property. Do not trespass on neighboring lots.
- Dogs must be leashed or confined to the property if unleashed. Dogs are not permitted in the PMC lakes, on the Clubhouse grounds or walkways or in Lampkin Park. Service animals are the only exception.
- Loud, noxious or offensive activity is prohibited.
- Remember that PMC enforces dark sky rules.

Parking

• On-street parking is prohibited yearround. Parking is permitted on neighboring lots with written permission of the owner.

Camping

• Camping is permitted in the PMC Campground only. Motor homes or trailers may not be inhabited on private property. Camping spaces may be reserved through the PMC office.

Sharing the Forest with Wildlife

- When driving, be on the lookout for wildlife. Curvy streets require more frequent braking, and a deer or other creature may be around the next bend. The speed limit is 25 mph on community streets.
- Bears are a very real problem in PMC. Please see Page 1 of this Condor for bear safety tips, and adhere to the steps below.
- Do not feed wildlife or leave food outside to cool. Animals have a keen sense of smell.
- Remove all food from your car. Bears will damage a car if they smell food in it. That includes mints, scented air fresheners, lip balm or gum left in the glove box. Unattended food containers of any kind may not be left outside. Be aware of open doors, including the garage, while cooking food or when food containers are present.
- Trash must be kept indoors until taken to the Transfer Site.
- Barbecues should be cleaned completely after use and closed tightly.

A Message from the Board Chair

Given the fact that we have a new Board and a new fiscal year, I would like to take a few minutes to comment on our current and future status. It has been a tumultuous year. We have made mistakes, but your association is financially strong. There has been much discussion about transparency or the lack thereof. Addressing this issue begins with a clear understanding of our financial position.

The state of our finances is well reflected in the audited financial statements you received for the year ending June 2017. You will notice that the Operating Fund shows a cash balance of \$1,018,394. This number has been increasing over time. There seems to be some confusion as to what this number represents. If you review previous years, you will find this same number reflecting a growing reserve, eventually representing approximately 90 days of association expenditures.

This last year, because of the terrific efforts of GM Karin Shulman, CFO Kim Ryan and the staff, saving money where they could, we found ourselves with a substantial carryover and made the decision to include that carryover in the budget process. Future use of the fruits of this effort were discussed at the July Board meeting.

In 2007, due to the nationwide financial crisis that affected us all, the then new

General Manager, with the support of the Board, began to tighten up our operating expenses for the purpose of creating a buffer against a possible decrease in assessment collections and increase in foreclosures, precipitated by this financial crisis. We definitely experienced the realization of many of these fears, but not to the point of placing the finances of the association in real danger.

All the Boards for the past 10 years have continued this practice and the sum now represents a financially sound and responsible safety net of approximately 90 days of association expenditures. Our finances are strong and the economy is stable. The need for this backup has diminished. It is now time for a thoughtful discussion about the use of these funds.

Next month, we will receive the report of the Clubhouse Task Force. As you may remember, the group was formed after the members rejected the proposed master plan. It is my belief that they will provide us with a path forward and priorities to consider. I am sure that there will be continuing debate as to what to do and when. Once the Board has received the report, we will organize public meetings of the Board and Task Force to determine how to proceed.

In considering the potential use of the aforementioned monies, it is important to

remember that much needs to be done to even bring the association assets up to a safe level, i.e., plumbing and electrical. Spending available cash is always better than incurring debt. When we debated the resolution that was on the July Board meeting agenda, our renovation needs were a legitimate alternative use to what was being proposed. It is the responsibility of the Board to maintain the value of the assets of the association.

There are other issues the Board needs to address this year. Given the amount of time and effort put into the Condor Café, our results are abysmal. We need to review our approach and plot a new course going forward. The last two years have been marked by a series of petitions for Bylaw amendments that have not stood up to careful review. We can avoid that in the future. I propose that any Board member can bring forth member ideas and recommendations in the form of a resolution, and if approved, the Board will forward it to the Governing Documents Committee and legal for drafting and review. Finally, this Board will strive for more openness and transparency. We will continue to disagree and debate issues, but hopefully in the spirit of a common goal: the support of our members and the protection and enhancement of our services and assets.

Good news! Road resurfacing is complete. It lasted for just three days, but, unfortunately, even with signs posted on streets for two to three weeks prior; even with putting a notice in the Condor and on the website; and even with sending out an email blast; we still had people upset that they couldn't get out of their driveways. We have quite a few new people in our community who took alternate routes and got lost (including me!) and had to call the office for help with directions.

Next year, we will put out detour signs to help all of us. Also, another good idea we will implement next year is that once we know which streets are being resurfaced, we will drive around to figure out how to get to the highway using detours, and then make those routes known.

Pool, Projects and Post Office

The pool has been active with swimmers, and everyone looks like they are having a great time. Our new commercial heater has been put in and is working great.

The new fencing on the south side of the golf course (along Mil Potrero Highway) will start going up next week. Our tennis courts have been resurfaced, and the new wind screen is up. We have already had some vandalism with the new \$8,000 wind screen, as someone punched a hole in it and tried to push something through it. We will get it patched, but it is terrible that someone would get enjoyment out of punching a hole in the new screen.

We are in the process of preparing for our annual audit with field work beginning this month. We do not have a Teasurer's Report this month because the CFO was out of the office for two days. The CFO will be taking "draft" off the financial statements in the next few weeks, and we will repost the financials for 2017-2018. I would like to thank the members for their patience and understanding.

The United States Postal Service in Washington DC has sent the "Verification of Address" form to every post office box renter. This is the same form all of us complete each year for our local post office. So, even if you have renewed your box already in the past few months or will be renewing your box this month or next, this form must be completed and dropped off at the Post Office to satisfy the rules of the United States Postal Service., which we must follow.

Speaking of the post office, we had complaints from customers who say we are returning their packages, and they give the staff a very hard time. Did you know that in the last seven months we have had five different postmasters at the Frazier Park Post Office? This has made it very difficult to process some of our packages for PMC.

Customers who use zip code 93225 because the system doesn't recognize 93222 have been returned by the Frazier Park Post Office, not by our PMC Post Office staff. The Supervisor, Joannie, and her staff, work very hard to make our post office run smoothly. Joannie has spoken to the newest postmaster and explained the situation with the zip codes. The FP postmaster had no idea about our zip codes up here. He has assured us that he will inspect every package marked "Return to Sender" to ensure that it does not belong to PMC. All packages addressed with 93225 but containing either a PMC street or PO box will be forwarded to us.

Please think twice before you start getting angry with the staff. They really work hard to make sure you are happy with their service.

Golf Stats

In the month of June, there were 846 rounds of golf played and 256 buckets of balls hit. From July 1 to 19, there has been 574 rounds of golf played and 207 buckets of balls hit.

Rentals and Guest Cards

This is a reminder for those who rent out their cabins for weekends or as Airbnb units: If you are a member in good standing, you receive one to two member cards and four guest cards. On a member card, you can bring in up to six guests. Guest cards allow one guest per card. Yesterday, we had two homes rented for the weekend with 20 guests each. They were shocked when they were told that without a guest card, they could not get into the pool (only four guest cards per lot), recreation room or use the BBO facilities in the park. Remember, we are a private association, and the rules and bylaws apply to every owner and guest.

Swim Lessons

Last month, we had the Santa Barbara Swim Team provide swimming lessons for free to anyone who wanted to take advantage of it, and there has been a lot of positive feedback from the members. And the summer fun isn't over yet; activities and camps continue this month.

Condor Cafe News

The Condor Café is now open seven days a week again for breakfast and lunch. We will start dinners again August 3rd, and dinners will be served downstairs in the Condor Café. We will send out an email blast with, yet again, another new menu, which will include hamburgers on Friday nights along with low-

er-priced menu items. We were budgeted to lose \$227,699. The draft for the year-end total shows we reduced the subsidy by \$50,296. This has been a slow process through trial and error, but I believe we are on the right track. I will keep the membership posted.




